THE MAIN SUNDAY ENDURO

ADR will hold the 12th Annual Train Robbers Enduro in the same area as past years. **This will be a traditional TIME-KEEPING Enduro.** All bikes must have a Spark Arrestor and be \leq 99db to start. As per BJEC requirements, there will be a sound test (permanent sticker check) for all bikes *PRIOR TO SIGN-UP*. The practice track opens Saturday afternoon before and after the Kids Race). There will be no pre-riding on the course. **Proof of AMA membership (card or receipt) is required to enter.** The Rider's Meeting will start promptly at 7:00AM with a Key Time of 8:00AM.

ENTRY INFORMATION: The Pre-entry fee for regular A, B and C classes in this event is \$32.00. The fee for the BJEC Women and BJEC Youth classes is \$20.00. All entries postmarked after May 31st, as well as entries the weekend of the event, will be considered Late Entries and be \$37.00 (BJEC women and youth \$25.00). *There is no gate fee of any kind!* BJEC, SERA and TSCEC members can request a row, with fully paid entry. Postmarks will determine row priority. If the requested row is not available, the next *higher* available row will be assigned unless the rider requests otherwise (4 riders per row). Rows 20 to 30 will have priority to AA riders who pre-enter. (We do not work with credit cards nor do we accept Pay Pal.)

Please do not ask to ride on another person's entry money or ask to change rows. Weekend of event, sign-up and sound test will be open from noon to 6:00 PM on Saturday and 6:00 AM to 8:00 AM on Sunday. Look for the big red tent at West end of property for the sign-up area.

LOCATION: FROM THE EAST: Take the Social Hill exit (#91) off of Interstate 30 . Go **West**, on AR Hwy 84 approx. 15 miles to AR Hwy 7 in Bismark. Turn right, **North**, on Hwy 7 and go approx. 1 1/2 miles. Turn **right** onto County Road 818 (a dirt road). **Follow the arrows** to the camping and sign-up area (approx. 4 miles). FROM THE WEST: Take the AR Hwy 7 exit in Arkadelphia. Turn left and travel North to Bismark. Stay on Hwy 7 and cross AR Hwy 84. Follow remainder of directions above. Plenty of Parking. This is primitive camping. Quite time is from 10pm to 6am. **NO CAMP FIRES.**

SATURDAY KIDS/FAMILY ENDURO:

There will also be a "*Kids and Family Enduro*" held Saturday afternoon at 3:00 PM for youth, beginner and women riders. This event will have all classes recognized by both BJEC and SERA. A fun-run 12+ year old class for any BEGINNER will also be held. This will be a **BJEC AND SERA** points paying event. TSCEC and other "Kid/Family" riders are invited to participate, but will not earn circuit points. The format will be a National Format (mini) Enduro, with row numbers, mylars, flip cards and checkpoints. Time keeping not required. The club will provide clean-up riders and crossing personnel. This year BJEC's X-Rider concept will not be used. Entry for this event will be **\$10.00**. Sign-up will be from noon to 2:00PM. **Riders meeting at 2:30 PM AT THE STARTING LINE.** AMA membership is **NOT** required for this Kid's Event. All Checks and Known Controls will be within 1/2 mile of camp with easy spectator access. Pee Wee course cut-off. ☺
